We will sell on a charge basis, subject to the following terms and conditions:

1. You must submit a current credit application. A blank form for you to complete is on the reverse side. You must fill out the entire form, sign/print your name on the application, and return to R.E. Baker & Sons, Inc., PO Box 275, Clarendon, PA 16313.
2. We will examine your credit application, check your trade references, and notify you when your credit application has been approved. If we reject your application, you will be notified and given alternatives so you can do business with us.
3. Our TERMS or NET 15 DAYS on ALL credit purchases, with the exception of Pacific Pride, which offers a volume discount for purchases paid within 10 days. Invoices older than 30 days are subject to a finance charge of 1.5% per month for any balances owed as of the monthly statement date. Any account whose balance falls in the 60-90 day category in our monthly statement will automatically be placed on a COD (CASH ON DELIVERY) basis.
4. Should it be necessary to turn an account over to a collection agency, all collection costs, attorney fees, court costs, ect., will be added to the unpaid balance due.
5. We trust we have your complete understanding in this matter and that we may continue to serve you in the future.
